ABOUT THE PARKE WRIGHT III LEADERSHIP AWARD

The Leadership Tampa Alumni Parke Wright III Leadership Award recognizes a Leadership Tampa Alumnus who has demonstrated leadership above and beyond their job and made a significant difference in our community. The Parke Wright III Leadership Award will be presented at the Leadership Tampa Alumni Annual Meeting.

The award recipient will be able to honor the charity of his or her choice with a \$1,000 gift.

AWARD CRITERIA

To nominate an alumnus, please complete the official nomination form. **The recipient must be a member of Leadership Tampa Alumni and in good standing.** The current LTA Chair, GTCC Chair, LTA Vice-Chair, GTCC Chair Elect, GTCC Treasurer, LTA members serving on the Parke Wright III committee and current elected officials or candidates running for public office are not eligible for nomination. The following recognition criteria should be considered:

- How the person's leadership benefits the greater Tampa community.
- Whether the person's leadership activity involved any form of community service, including civic, cultural, economic, charitable, recreational, or educational.
- This award will not be given posthumously.
- Whether the person's demonstrated leadership is characterized by one or more of the following attributes:

CHARACTER

Moral, ethical, honest, courageous

COMMUNITY INVOLVEMENT

A demonstrated concern for community issues and volunteered time with service organizations to make a difference

INITIATIVE/TENACITY

Persistence, determination, perseverance, action and implementation

LEADERSHIP

Makes sound decisions and inspires others

**PROFESSIONAL
ACCOMPLISHMENTS**

Achievement, measurable results

SELFLESSNESS

Personal sacrifice, civic consciousness, social responsibility

VISION

Direction, foresight, creativity, new ideas, and resourcefulness to further the mission of Leadership Tampa and Leadership Tampa Alumni
