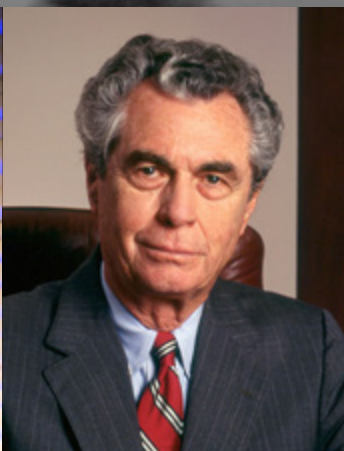

## ABOUT THE H.L. CULBREATH JR. PROFILE IN LEADERSHIP AWARD

Named in honor of its first recipient, a man whose civic philanthropy and long service personified leadership, the award has quickly become the area's most prestigious honor.

This award, established by Leadership Tampa Alumni, will be presented at the Greater Tampa Chamber of Commerce's Annual Meeting on December 14<sup>th</sup> at the Tampa Convention Center. It recognizes leadership in a variety of forms such as civic, cultural, economic, charitable, recreational and education.

<b>LEADERSHIP</b>	Demonstrates the ability to lead in his/her business
<b>PROFESSIONAL ACCOMPLISHMENTS</b>	Shows achievement through measurable results; demonstrates career achievement
<b>SELFLESSNESS</b>	Offers personal sacrifice, generosity, philanthropy and social conscience
<b>VISION</b>	Has direction, foresight, creativity and resourcefulness
